**Process for Eliminating Investment Options**

After market close on **Thursday, July 12, 2007**, no participant transactions will be allowed until **Friday, July 13, 2007**, when your Plan will be fully open to participant transactions beginning approximately mid-morning. Any allocation of ongoing deferrals to the eliminated fund will be redirected to the replacement fund, as shown below, unless you change your investment allocations prior to July 12, 2007.
