Mr. Lynch made a motion the Committee accept the disability recommendations from staff. Mr. Parsons seconded the motion. The motion carried unanimously.

Tab #3 Disability Claims Management Discussion

Director Fleck and Deputy Director Miller discussed with the Committee the potential of having MMro manage disabilities for the CPRB.

Upon request, Executive Director Fleck stated that he would call other states to see if they are satisfied with the disability claims service provided by MMro and any cost savings their plans have seen. Also, Director Fleck would get a cost proposal from MMro and report back to the Committee at the next meeting.

Discussion occurred regarding consistency in medical reports, members being equally assessed by physicians and strengthening evidence for litigation. Statutory amendments will need to be made during the 2014 Legislative session to most plans.
